

"New Beginnings for Every Generation"

PLAN OF PURPOSE

- Begin funding each component of Z-H.O.P.E.™ as well as solicit celebrities to cosponsor the Sorority's efforts.
- Begin cutting the budget by at least 25% & continue the current payment schedule to have a zero (\$0) balance on the National Headquarters Renovation loan in 8 years.
- Begin action immediately on items outlined in the Blue Ribbon Task Force Report.
- 4. Begin interaction with the 2nd Anti-Basileus & the National Educational Foundation to establish 10 scholarships (different fields and disciplines of study) in \$10,000 increments for a period of 10 years for a one million dollar endowment. One of the scholarships will be in honor of Soror Zora Neale Hurston for the study of anthropology and folk literature and will be awarded in conjunction with the festival in Eatonville, FL.
- Begin focusing on Headquarter operations in the areas of data management, quality control, distribution, and standard operating procedures.
- Begin underwriting ZOL™, utilizing leaders in the field of business and politics to serve as facilitators.
- Begin collaboration of combining the ZOL™ training with the Leadership Conference. Begin incorporating sponsorships from external organizations and speakers during the Leadership Conference what will provide additional funding to reduce cost to participants.
- Begin distributing financial reports & FYI's to the membership on a quarterly basis as well as establishing a consistent Archon schedule.
- Begin a National Undergraduate & Youth Summit that will focus on the areas of Leadership, Training, Business
 Politics, as well as Zeta's internal structure, policies and procedures.
- Begin the renovations of Birch Haven that the executive board approved in January '07 now that we have completed National Headquarters.
- 11. Begin a MiP Task Force to include the 1st & 3rd Anti-Basilei, and the Graduate & Undergraduate Member-At-Large to revisit our policies & improve procedures. Publish a MIP Toolkit on things undergraduates and graduates can do, now that we have outlined what can't be done.
- Begin a training curriculum for Regional & State Directors while they are in office regarding programmatic thrust, policy & procedures, event planning, and goals.
- Begin an active group for Zetas & Amicae that have served the sisterhood for 50+ years and provide them with "royal" treatment. They will be known as our "DOVES".
- 14. Begin a "Distinguished Pearl Chapter" that will induct members that have exemplified the highest ideals of service in the sorority and their local communities. They will be called "PEARLS" because they are always Pursuing Excellence And Rendering Loyal Service.
- 15. Begin organizing competitions on the state and regional level in an effort to find Zeta's Best Steppers to represent Zeta Phi Beta Sorority, Inc. in movies, magazines, radio, and television. These Sorors will become Zeta's National Step Team.
- 16. Begin a Zeta National Choir to compete in various GospelFests and perform at special events. Provide entertainment at Boulé during our Inspirational Breakfast and have the opportunities to proved backup vocals for our celebrity guests.
- Begin structuring the Boulé over 4 days with a Saturday night stay to reduce cost for attendee's airfare & hotel.

CRITERIA AND GUIDELINES

The Competition

All active and financial chapters within the Great Lakes Region are strongly encouraged to participate in the 2011 REGIONAL MODEL CHAPTER REPORT competition during the 77th annual Great Lakes Regional Conference. This year, there is a special call for Amicae and Youth groups to participate as well. We know your chapter/group has had stellar programs and exemplified the principles of our great sorority in the most phenomenal way. We can't wait to see! Remember, this is not the Scrapbook competition; however, we encourage you to enter that as well. All materials for this competition must be typed, double spaced and bound together in report form. Pretend you are presenting your annual report to investors and stockholders. Make us want to "show you the money." Well developed reports with documentation and information in each subject area will identify the "Model Chapter."

Why the change from "Chapter Report" to "Regional Model Chapter Report" competition?

Why not? With the number of great things that you are doing in your respective chapters and auxiliary groups, it is important to recognize your work! Regional Director McCoy wants to make sure that "model" chapters and auxiliaries have their "time to shine" and be recognized for everything they are doing on all levels of the sisterhood.

Preparing your report

Preparing your chapter or auxiliaries report should be a fun time for reflection and embellishment for your chapter members! This report should not be a chore or burden for one person. The committee encourages creativity in organizing your report. The preparation of the report can be simple by encouraging chapter chairpersons to write their respective sections and submit them to the chapter report "coordinator." The information below may be used as a basic guide when preparing your report; however, you are encouraged to dig deep, be detailed, and show your creativity through your presentation. Identification and record of the size of your chapter is necessary to compare and categorize those chapters that differ in the size of membership. (See "How will my chapter's report be judged/graded?").

- 1. All reports must have the chapter's name and/or auxiliary information for identification purposes and be labeled 2011 REGIONAL MODEL CHAPTER REPORT. Cover sheets must be submitted with reports.
- 2. All reports must outline and incorporate the following: Zeta Principles, National Programs, National Observances, the International Grand Basileus' National Programmatic Thrust, the Regional Director's Programmatic and Organizational Focus, Conferences, Awards and Honors, Greek Unity and Collaboration, sponsorship of Undergraduate chapters and auxiliaries (graduate chapters only), Campus activities (undergraduate chapters only), Community activities, collaboration and coordination with other Greek auxiliaries, youth groups and community organizations (Amicae and youth groups only). In addition, all reports will be judged on organization, grammar, originality/creativity, and overall presentation. BE CREATIVE!!!!
- 3. Supporting documents (thank you letters, letters of appreciation, programs, flyers, marketing and advertisement materials) for any chapter and/or auxiliary (co)sponsored activities are **strongly** encouraged to accompany your report.
- 4. Reports should be organized in an orderly and neat fashion. A table of contents is always helpful and allows information to be found more easily.
- 5. All reports must be typed.





Submitting your report

Chapters and groups are asked to submit an electronic **INTENT TO PARTICIPATE** form by 5 p.m. April 15, 2011. The form the form will be sent to all chapters. Submission of the form allows the committee to know in advance how many reports we will likely be judging. All chapters and groups entering the competition must submit their own reports (with the appropriate identification form) to the designated location by the designated time. To ensure safe arrival, all chapters are asked to transport their own reports to the Regional Conference. The Chair will not accept reports electronically, or via USPS, prior to or during the conference. Entries not following the specified guideline or containing inappropriate material will be disqualified. A computer will be provided during judging. Chapters and groups utilizing this technology are also required to submit a hard copy of your report.

Who are the Judges?

No later than **April 4, 2011,** State Directors are asked to submit names and contact information of no more than two (2) Sorors (graduate and undergraduate) to serve on the committee. Names can be submitted from State Directors to the Chair at guinn1tl@cmich.edu. To ensure fairness, only two Sorors per state will be permitted to judge and will be accepted on a first come, first serve basis from the State Directors. The Chair will serve as the facilitator only, coordinating the process and not holding a vote during the review of reports.

How will my chapter's report be judged/graded?

Each submitted report will be evaluated no more than three (3) times by committee members. Committee members are not allowed to judge/grade their own chapter's reports nor reports from their respective states. Graduate Sorors will be asked to judge undergraduate chapters, Amicae and youth groups. Undergraduate Sorors will be asked to judge graduate chapters, Amicae and youth groups. The judges will evaluate the chapter reports using the following grading procedures. **Total possible points: 192**

Resolution Committee **Empowering Voice Soror Trudy Hale**

A **resolution** is a motion that needs emphasis because of its length or complexity.

The function of the Resolutions Committee is to coordinate the development of resolutions that reflect the needs of the Great Lakes region.

PARTS OF A RESOLUTION:

Preamble

The preamble is that portion of the resolution which might be considered debate; it explains why the resolving clause(s) should be adopted.

The preamble begins with "Whereas" followed by a comma and the next word begins with a capital letter.

There should be no periods in a preamble. Each paragraph ends with a semicolon;

The next to the last paragraph also includes "and". Since the preambles have no legal importance, amendments to them are not in order until the resolution is adopted-then they are brought into conformity.

The last paragraph of the preamble ends with a semicolon and may contain "therefore" e.g. "be it therefore, resolved."

Resolving clause(s):

The words "resolved" is printed in Italics or underlined. It is followed by a comma and the word "that which" is capitalized.

If there is more than one resolving clause, each begins with "Resolved at That......"

Resolving clauses end with a semicolon.

Next to the last clause add "and" as in the preamble.

A resolution should be written in this form:

Whereas, the Executive Board...; and

Whereas, The membership....; and

Whereas, The Regional Director...; Therefore be it

Resolved, That....:

NOTES FOR THE RESOLUTIONS COMMITTEE

All resolutions shall be signed by the author

Resolutions should be numbered

The committee chair should report for the committee.

After reading a resolution, "I move adoption of this resolution." No second is required.




